Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

## **CITATION**

A Citation is hereby issued to The Esani Institute, LLC, Owner of The California Academy, Inc., dba Paul Mitchell The School Sacramento (Institution) located at 2100 Arden Way, Suite 265, Sacramento, CA 95825, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

#### BACKGROUND

On March 6, 2019, Bureau staff conducted an unannounced compliance inspection at the Institution. The Institution was issued Notice to Comply #CU 50085278 0319 (NTC) as a result of three minor violations that were unable to be cleared before the end of the inspection. The Institution was given thirty days from the date of the inspection to either remedy all violations listed in the NTC or submit a written Notice of Disagreement. A Notice of Disagreement was not received, and the Institution was able to clear two of the three violations.

#### VIOLATION

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **January 2, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.
