Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

# **CITATION**

A Citation is hereby issued to American Business College, Inc., Owner of The Accounting Academy, (Institution) located at 7283 Engineer Road, Suite H, San Diego, CA, 92111, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

### BACKGROUND

On June 19, 2019, an unannounced Compliance inspection was conducted at the Institution. Bureau staff requested the supporting documentation for the 4<sup>th</sup> quarter of 2018 and 1 quarter of 2019 Student Tuition Recovery Fund (STRF). The Institution representative was unable to provide the supporting documentation and stated that the supporting documentation was not on-site and would not have access during the inspection.

Additionally, Bureau staff requested the supporting documentation for the 2016-2017 School Performance Fact Sheets (SPFS). Bureau staff reviewed the supporting documentation and determined that the documentation was missing several required data points per 5, CCR Section 74112 (m)(1-9). The Institution representative stated that the missing data points could not be added to the supporting documentation during the inspection.

# ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of **\$5,500.00** for the violations described above. **Payment must be made, to the Bureau, within** <u>**30 days**</u> from the date of service of the Citation.

### **COMPLIANCE WITH ORDER OF ABATEMENT**

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within** <u>30 days</u> from the date of service of the Citation.

# APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **March 8, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

### **EFFECTIVE DATE OF CITATION**

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **February 7, 2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **March 8, 2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
