Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

## **CITATION**

A Citation is hereby issued to The Independent Training and Apprenticeship Program d/b/a ITAP, Owner of Independent Training & Apprenticeship Program (I-TAP) (Institution) located at 856 Business Park Drive, Sacramento, CA, 95827, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

## **BACKGROUND**

On September 11, 2019, Bureau staff conducted an announced Compliance inspection at the Institution. Bureau staff reviewed graduated and withdrawn/cancelled student files and found a material violation related to student transcripts.

### **VIOLATION**

(A) The courses or other educational programs that were completed, or were attempted but not

completed, and the dates of completion or withdrawal;"

## 5, CCR Section 71930(b)(1) - Maintenance of Records

"(b)(1) In addition to permanently retaining a transcript as required by section 94900(b) of the Code, the institution shall maintain for a period of 5 years the pertinent student records described in Section 71920 from the student's date of completion or withdrawal."

Bureau staff reviewed graduated and withdrawn/cancelled student files and found that the Institution failed to maintain a transcript showing courses that were completed, or courses that were attempted but not completed, and the dates of completion or withdrawal.

### **Order of Abatement:**

The Bureau orders the Institution to submit a policy, or procedure, of how future compliance with 5, CCR sections 71920 and 71930 will be maintained.

## **Assessment of Fine**

The fine for this violation is \$2,000.00

# **TOTAL ADMINISTRATIVE FINE DUE: \$2,000.00**

### ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of \$2,000.00 for the violations described above. Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

### COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days** from the date of service of the Citation.

### **APPEAL OF CITATION**

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **August 29, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

### EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **July 30, 2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **August 29, 2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
