On February 4, 2021, an informal telephone conference was held in the matter of Citation: Order of Abatement No. 2021154 (Citation) against Austin University, Owner of Austin University (Institution). In attendance were Beth Scott, Enforcement Chief, and Ashraf Al Moustafa, Owner.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 2021154.

It is the decision of the Enforcement Chief that on February 11, 2021, Citation No. 2021154 is <u>modified</u> and makes the following change(s):

Reason for Modification: New substantive facts were presented at the conference.

### **EFFECTIVE DATE OF CITATION**

This modified Citation is effective on **February 25, 2021**. The Order of Abatement is due by **March 27, 2021**.

Failure to abate the violation within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
