### LICENSING HISTORY

On or about June 30, 2015, the Bureau renewed an Approval to Operate a Private Postsecondary Institution, Institution Code 1921011, to American Institute of Education formerly known as AMERICAN INSTITUTE OF EDUCATION, hereinafter referred to as the "Institution". This Approval to Operate expired on or about June 29, 2020, and has not been renewed. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on May 9, 2024, and is under review.

# CAUSE FOR CITATION & ASSESMENT OF FINE AND/OR ORDER OF ABATEMENT

4. The Institution is in violation of the following Bureau laws and regulations:

### Violation #1:

## 5 CCR section 71930 (e) – Maintenance Records

Cause for Citation: On or about January 18, 2024, the Bureau conducted an unannounced compliance inspection pursuant to CEC 94932.5 (a). Bureau staff requested to review the Institution's 2021 School Performance Fact Sheet (SPFS) supporting data. The Institution only provided partial information due to changes in ownership and lack of data collected from previous ownership. Therefore, the Institution was unable to make the records immediately available for inspection.

**Administrative Fine:** Pursuant to 5 CCR section 75030, the Bureau has determined this to be a "Class C" violation. The Institution is issued a fine of \$501.00.

**Order of Abatement:** Pursuant to 5 CCR section 75020, the Bureau issues the following order of abatement:

The Bureau orders the Institution to submit a statement of attestation they have corrected the violation and will ensure that the supporting data for SPFS is maintained and immediately available during an inspection. The statement of attestation must be dated and signed by an authorized representative of the Institution.

## Violation #2:

CEC section 94935 (b) - Notice to Comply in conjunction with 5 CCR 75010 (h)

**Cause for Citation:** On or about January 18, 2024, Bureau staff issued a Notice to Comply (NTC) for violations of CEC section 94913 (a)(5) and CEC section 94913 (a)(1) Institutional Web Site Requirements in conjunction with 5 CCR section 71810 (a) Catalog.

The Institution failed to remedy the noncompliance for violation #2, as noted in the Notice to Comply by the due date of February 17, 2024.
