On September 15, 2022, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 2223013 (Citation) against Nurses' Development Center, Inc., Owner of Nurses' Development Center, Inc (Institution). In attendance were Ebony Santee, Licensing Chief, Arminda Crockett, President, and Zoila Hinton, Office Manager.

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 2223013.

It is the decision of the Licensing Chief that on October 4, 2022, Citation No. 2223013 is <u>modified</u> and makes the following change(s):

phone number and email address, and all written communication with employer verifying student's employment or salary;

(5) for students who become self-employed, all documentation necessary to demonstrate self-employment;

(6) a description of all attempts to contact each student. or employer;

(7) any and all documentation used to provide data regarding license examinations and examination results;

(8) for each student determined to be unavailable for graduation or unavailable for employment, the identity of the student, the type of unavailability, the dates of unavailability, and the documentation of the unavailability; and

(9) the name, email address, phone number, and position or title of the institution's representative who was primarily responsible for obtaining the students' completion, placement, licensing, and salary and wage data, the date that the information was gathered, and copies of notes, letters or emails through which the information was requested and gathered."

5, CCR Section 71930 - Maintenance Records

"(e) All records that the institution is required to maintain by the Act, or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations."

During the onsite inspection, Bureau staff requested the supporting documentation for the data reported on the most current SPFS. Bureau staff were provided the supporting data and found that the Institution was not tracking all of the required data.

Order of Abatement:

The Bureau orders the Institution to submit the supporting documentation for the most current SPFS that includes all required data. In addition, the Bureau orders the Institution to submit a written policy, or procedure, of how the Institution will maintain future compliance with 5, CCR Section 74112.

Assessment of Fine

The fine for this violation is <u>\$5,000.00</u>

<u>Reason for modification</u>: New substantive facts were presented at the conference.

The administrative fine for this violation has been modified from \$5,000.00 to <u>\$3,500.00</u>.

TOTAL MODIFIED ADMINISTRATIVE FINE DUE: \$3,500.00

EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on **October 13, 2022**. The Order of Abatement and payment are due by **November 12, 2022**.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
