On or about January 21, 2016, the Bureau renewed an Approval to Operate a Private Postsecondary Institution to The Hatlen Center for the Blind, a Program of Wayfinder Family Services (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about January 20, 2021, and has not been renewed.

2. The Institution has no prior discipline history.
