Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

CITATION

A Citation is hereby issued to A F International School of Languages, Inc., Owner of A F International School of Languages, Inc., (Institution) located at 3807 Wilshire Blvd., Suite #1140, Los Angeles, CA 90010, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On August 28, 2019, Bureau staff attempted to conduct an unannounced Compliance inspection at the Institution. Bureau staff met with the Owner of the Institution who stated the school would be closing for the day and that the Institution did not have a representative available onsite to be able to assist with Compliance inspection. Bureau staff left the Institution unable to conduct the inspection.

VIOLATION

On August 28, 2019, at approximately 12:00 p.m., Bureau staff attempted to conduct an unannounced Compliance inspection at the Institution. The Owner informed Bureau staff that the Institution was closing early and there were not personnel available onsite to assist with the inspection. The Institution failed to have personnel available during the Institution's posted business hours of 9:00 a.m. to 1:30 p.m., in violation of 5, CCR section 71930 (e).

Order of Abatement:

The Bureau orders the Institution to submit a written policy of how compliance with 5, CCR section 71930 (e) will be maintained.

Assessment of Fine

The fine for this violation is \$5,000.00

ASSESSMENT OF A FINE

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of \$5,000.00 for the violations described above. Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days from the date of service of the Citation.

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation - Request for Informal Conference and/or Administrative Hearing' form (enclosed) within 30 days from the date of service of the Citation. If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time. Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by March 4, 2020, you will be deemed to have waived or forfeited your right to appeal this matter.
