28	Vocational Institute (Respondent). Between October 2020 and June 2022, the Bureau and

- "(6) The institution is financially sound and capable of fulfilling its commitments to students.
- "(7) That, upon satisfactory completion of an educational program, the institution gives students a document signifying the degree or diploma awarded.

. . .

- "(9) The institution is maintained and operated in compliance with this chapter and all other applicable ordinances and laws."
 - 7. Section 94886 states:

"Except as exempted in Article 4 (commencing with Section 94874) or in compliance with the transition provisions in Article 2 (commencing with Section 94802), a person shall not open, conduct, or do business as a private postsecondary educational institution in this state without obtaining an approval to operate under this chapter."

8. Section 94887 states:

"An approval to operate shall be granted only after an applicant has presented sufficient evidence to the bureau, and the bureau has independently verified the information provided by the applicant through site visits or other methods deemed appropriate by the bureau, that the applicant has the capacity to satisfy the minimum operating standards. The bureau shall deny an application for an approval to operate if the application does not satisfy those standards."

- 9. Section 94891 states, in part:
- "(a) The bureau shall adopt by regulation the process and procedures whereby an institution may obtain a renewal of an approval to operate.
- "(b) To be granted a renewal of an approval to operate, the institution shall demonstrate its continued capacity to meet the minimum operating standards.
- "(c)(1) An institution that is denied renewal of an approval to operate may file an appeal in accordance with the procedures established by the bureau pursuant to Section 94888.
- "(2) An institution that has filed an appeal of a denial of a renewal application may continue to operate during the appeal process, but must disclose in a written statement, approved by the bureau, to all current and prospective students, that the institution's application for renewal of

approval to operate was denied by the bureau because the bureau determined the application did not satisfy the requirements to operate in California, that the institution is appealing the bureau's decision, and that the loss of the appeal may result in the institution's closure.

STATUTORY AND REGULATORY PROVISIONS

10. Section 94908 states:

"Any information or statement required by this article to be included in the catalog, School Performance Fact Sheet, or enrollment agreement shall be printed in at least the same size font as the majority of the text in that document."

11. Section 94909 states, in part:

"(a) Except as provided in subdivision (d), before enrollment, an institution shall provide a prospective student, either in writing or electronically, with a school catalog containing, at a minimum, all of the following:

. . .

"(10) A statement reporting whether the institution participates in federal and state financial aid programs, and if so, all consumer information that is required to be disclosed to the student pursuant to the applicable federal and state financial aid programs.

. . .

"(15) The following statement:

"NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION

"The transferability of credits you earn at (name of institution) is at the complete discretion of an institution to which you may seek to transfer. Acceptance of the (degree, diploma, or certificate) you earn in (name of educational program) is also at the complete discretion of the institution to which you may seek to transfer. If the (credits or degree, diploma, or certificate) that you earn at this institution are not accepted at the institution to which you seek to transfer, you may be required to repeat some or all of your coursework at that institution. For this reason you should make certain that your attendance at this institution will meet your educational goals. This

"(c) The description of the physical facilities shall include building diagrams or campus
maps to assist the Bureau in locating these facilities. The diagrams or maps shall identify the
location of classrooms, laboratories, workshops, and libraries.

- "(d) The description shall include specifications of significant equipment that demonstrate that the equipment meets the standards prescribed by the Code and this chapter and is sufficient to enable students to achieve the educational objectives of each education program.
- "(e) For each item of significant equipment, the description shall indicate whether the equipment is owned, leased, rented, or licensed for short- or long-term, or owned by another and loaned to be used without charge.
- "(f) The Form Application 94886 shall contain a list of all permits, certifications, or other evidence of inspections or authorizations to operate required by the jurisdictions within which the institution operates that the institution has obtained, and/or an explanation as to why those permits, certifications, or inspections have not yet been obtained."
 - 15. California Code of Regulations, title 5, section 71475 states, in part:

. .

"(c) The application for renewal of approval to operate and offer educational programs for non-accredited institutions shall include all of the following:

.

- "(2) The physical address of the institution's primary administrative location in California.
- "(3) The mailing address, identified either by physical address or by post office box number, telephone number and fax number of the institution.

. . .

"(6) The form of business organization of the institution (e.g., sole proprietorship, general or limited partnership, for-profit corporation, nonprofit corporation, or Limited Liability Corporation). If the institution is incorporated, the institution shall also identify the state within which the institution is incorporated and the date of incorporation, and provide copies of the articles of incorporation and bylaws.

"(e) The institution shall submit at the time it applies for renewal current financial statements that meet the requirements of section 74115 as follows: (1) for an institution with annual gross revenues of \$500,000 and over, statements shall be audited; (2) for an institution with annual gross revenues less than \$500,000, statements shall be reviewed.

. . .

"(r) The institution shall identify and describe, in the application, the educational program it offers, or proposes to offer. If the educational program is a degree program, the institution shall identify the full title which it will place on each degree awarded. If there have been no substantive changes since the last submission, the institution may so state and is not required to submit documentation.

. . .

- "(t) In addition, the institution shall list in the application, the following for each educational program offered unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.
- "(1) The admissions requirements, including minimum levels of prior education, preparation, or training;

. . .

- "(3) The types and amount of general education required;
- "(4) The title of the educational programs and other components of instruction offered, including a description of the level of the courses (e.g., below college level, undergraduate level, graduate level);
 - "(5) The mode of instruction;
 - "(6) The graduation requirements.
- "(7) Whether the educational program is designed to fit or prepare students for employment in any occupation. If so, the application shall identify each occupation and job title to which the institution represents the educational program will lead.

/////

"(u) For each educational program that the institution offers or proposes to offer, the
application shall contain a statement that the educational program meets the requirements of
section 71710, as well as the following unless there have been no substantive changes since the
last submission. If there have been no substantive changes made the institution may so state and is
not required to provide documentation:

- "(1) A description of the educational program.
- "(2) A description of the equipment to be used during the educational program.
- "(3) A description of the number and qualifications of the faculty needed to teach the educational program.
- "(4) A projection, and the bases for the projection, of the number of students that the institution plans to enroll in the educational program during each of the three years following the date the application was submitted.
- "(5) A description of the learning, skills, and other competencies to be acquired by students who complete the educational program.

"(7) Upon request, the institution shall provide to the Bureau copies of the curriculum or syllabi required pursuant to section 71710.

"(w)(2) The institution shall submit current, audited financial statements at the time it applies for approval to operate. Each set of financial statements shall comply with Section 74115 of this chapter.

"(y)(1) For each program offered, the application shall contain a description of the facilities and the equipment which is available for use by students at the main, branch, and satellite locations of the institution unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.

- "(2) For facilities that are leased or rented, the application shall contain the name and address of the lessor or landlord, together with a copy of any use, lease, or rental agreements for the facilities unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.
- "(3) The application shall include, in addition to the description of the physical facilities, building diagrams or campus maps to assist the Bureau in locating these facilities. The diagrams or maps shall identify the location of classrooms, laboratories, workshops, and libraries unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.
- "(4) The description in the application shall include specifications of significant equipment that demonstrate that the equipment meets the standards prescribed by the Code and this chapter and is sufficient to enable students to achieve the educational objectives of each education program unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.
- "(5) For each item of significant equipment, the description in the application shall indicate whether the equipment is owned, leased, rented, or licensed for short- or long-term, or owned by another and loaned to be used without charge unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.
- "(6) The application shall contain a list of all permits, certifications, or other evidence of inspections or authorizations to operate required by the jurisdictions within which the institution operates that the institution has obtained, and/or an explanation as to why those permits, certifications, or inspections have not yet been obtained unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.

(cc) The institution shall submit with the application, a copy of the document that is ed to a graduating student upon successful completion of each educational program unless there have been no substantive changes since the last submission. If there have been no substantive changes made the institution may so state and is not required to provide documentation.

"(ee) The application shall contain a description of the procedures used by the institution to assure that it is maintained and operated in compliance with the Act and this Division.

California Code of Regulations, title 5, section 71700 states:

"The Bureau may request that an institution document compliance with the standards set forth in the Act and this Division to obtain and maintain an approval to operate."

California Code of Regulations, title 5, section 71710, subdivision (c) states:

"In order to meet its mission and objectives, the educational program defined in section 94837 of the Code shall be comprised of a curriculum that includes:

- "(c) course or module materials that are designed or organized by duly qualified faculty. For each course or module, each student shall be provided with a syllabus or course outline that contains:
 - "(1) a short, descriptive title of the educational program;
 - "(2) a statement of educational objectives;
 - "(3) length of the educational program;
 - "(4) sequence and frequency of lessons or class sessions;
 - "(5) complete citations of textbooks and other required written materials;
- "(6) sequential and detailed outline of subject matter to be addressed or a list of skills to be learned and how those skills are to be measured;
 - "(7) instructional mode or methods."

- 18. California Code of Regulations, title 5, section 71720, subdivision (b) states:
- "(b) Instructors in an Educational Program Not Leading to a Degree.
- "(1) An institution shall employ instructors who possess the academic, experiential and professional qualifications to teach, including a minimum of three years of experience, education and training in current practices of the subject area they are teaching. If an instructor does not possess the required three years of experience, education and training in the subject area they are teaching, the institution shall document the qualifications the instructor possesses that are equivalent to the minimum qualifications.
- "(2) Each instructor shall maintain their knowledge by completing continuing education courses in his or her subject area, classroom management or other courses related to teaching.
- "(3) The institution shall not employ or continue to employ an instructor who was adjudicated in a judicial or administrative proceeding as having violated any provision of the Act or this chapter, or as having committed any act that would constitute grounds for the denial of a license under Section 480 of the Business and Professions Code."
 - 19. California Code of Regulations, title 5, section 71745 states:
- "(a) The institution shall document that it has at all times sufficient assets and financial resources to do all of the following:
- "(1) Provide all of the educational programs that the institution represented it would provide.
- "(2) Ensure that all students admitted to its educational programs have a reasonable opportunity to complete the programs and obtain their degrees or diplomas.
 - "(3) Maintain the minimum standards required by the Act and this chapter.
 - "(4) Pay timely refunds as required by Article 13 of the Act.
 - "(5) Pay all operating expenses due within 30 days.
- "(6) Maintain a ratio of current assets to current liabilities of 1.25 to 1.00 or greater at the end of the most recent fiscal year when using generally accepted accounting principles, or for an institution participating in Title IV of the federal Higher Education Act of 1965, meet the composite score requirements of the U.S. Department of Education. For the purposes of this

section, current assets does not include: intangible assets, including goodwill, going concern value, organization expense, startup costs, long-term prepayment of deferred charges, and non-returnable deposits, or state or federal grant or loan funds that are not the property of the institution but are held for future disbursement for the benefit of students. Unearned tuition shall be accounted for in accordance with general accepted accounting principles.

- "(b) At an institution's request, the Bureau may consider the financial resources of a parent company if the parent company, as defined by section 94853 of the Code, meets and maintains all of the following provisions:
 - "(1) consents in writing to be sued in California;
- "(2) consents in writing to be subject to the jurisdiction of the Bureau with respect to the institution's regulation under the Act and this Chapter;
- "(3) designates and maintains an agent for service of process, consistent with section 74190;
- "(4) agrees in writing to pay any refund, claim, penalty, or judgment that the institution is obligated to pay; and
- "(5) files financial reports, maintains financial records, and consents in writing to permit the inspection and copying of financial records to the same extent as is required of the institution.
- (c) An institution shall provide to the Bureau its most current financial statements upon request."
 - 20. California Code of Regulations, title 5, section 71810, subdivision (b)(1) states:
- "(b) The catalog shall contain the information prescribed by Section 94909 of the Code and all of the following:
- "(1) The specific beginning and ending dates defining the time period covered by the catalog;"
 - 21. California Code of Regulations, title 5, section 74115 states, in part:
- "(a) This section applies to every set of financial statements required to be prepared or filed by the Act or by this chapter.

- "(b) A set of financial statements shall contain, at a minimum, a balance sheet, an income statement, and a cash flow statement, and the preparation of financial statements, shall comply with all of the following:
- "(1) Audited and reviewed financial statements shall be conducted and prepared in accordance with the generally accepted accounting principles established by the American Institute of Certified Public Accountants by an independent certified public accountant who is not an employee, officer, or corporate director or member of the governing board of the institution.
- "(2) Financial statements prepared on an annual basis as required by section 74110(b) shall be prepared in accordance with the generally accepted accounting principles established by the American Institute of Certified Public Accountants. Nonprofit institutions shall provide annual financial statements as required under generally accepted accounting principles for nonprofit organizations.
- "(3) The financial statements shall establish that the institution meets the requirements for financial resources required by Section 71745.

. . . . ,,

- 22. California Code of Regulations, title 5, section 76215, subdivision (a) states:
- "(a) A qualifying institution shall include the following statement on both its enrollment agreement and school catalog:

"The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

'You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program."

FIRST CAUSE FOR DENIAL OF APPLICATION

(Institution Physical and Mailing Addresses)

23. Respondent's renewal application is subject to denial on the grounds that it does not include the physical address of the institution's primary administrative location in California and the institution's mailing address, identified either by physical address or by post office box number. (Educ. Code §§ 94885, subd. (a)(3) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71700 and 71475, subd. (c)(2) and (c)(3).) In particular, the renewal application contains Respondent's prior physical and mailing addresses.

SECOND CAUSE FOR DENIAL OF APPLICATION

(Articles of Incorporation and Bylaws)

24. Respondent's renewal application is subject to denial on the grounds that it fails to offer details regarding its form of business organization. (Educ. Code §§ 94885, subd. (a)(9) and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71700 and 71475, subd. (c)(6).) In particular, Respondent failed to offer any documents or information establishing how Micro-Easy Computer Enterprises, Inc. is related to Micro-Easy Vocational Institute.

THIRD CAUSE FOR DENIAL OF APPLICATION

(Student Agreements)

- 25. Respondent's renewal application is subject to denial on the grounds that it does not include a compliant enrollment agreement. (Educ. Code §§ 94885, subd. (a)(2) and (a)(9) and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71700). In particular:
- a. The font in Respondent's proposed enrollment agreement is not printed in the same size font as the majority of the text in that document. (Cal. Educ. Code § 94908).
 - b. Respondent's proposed enrollment agreement does not include the language,

regarding the Student Tuition Recovery Fund (STRF), required by California Code of

Regulations, title 5, section 76215, subdivision (a).

c. Respondent's requisite transferability disclosure, in its enrollment agreement, is

incomplete and not entirely legible. (Educ. Code §§ 94909, subd. (a)(15) and 94911, subd. (h).)

d. Respondent's proposed enrollment agreement contains a statement required by Education Code section 94911, subdivision (j)(1), but that statement is incomplete and not entirely legible.

FOURTH CAUSE FOR DENIAL OF APPLICATION

(Instruction and Degrees Offered)

- 26. Respondent's renewal application is subject to denial on the grounds that it fails to provide details regarding educational programs, admission requirements, graduation requirements, and faculty. (Educ. Code §§ 94885, subds. (a)(1), (2), (3), (5), (7) and (9), and 94891, subd. (b); and Cal. Code Regs., title 5, § 71700).
- a. Respondent failed to identify and describe the educational program (or programs) it offers or proposes to offer. (Cal. Code Regs., title 5, § 71475, subd. (r).)
- b. Respondent failed to list the admissions requirements, including minimum levels of prior education, preparation, or training, for each educational program offered. (Cal. Code Regs., title 5, § 71475, subd. (t)(1).)
- c. Respondent failed to list the types and amount of general education required for each educational program offered. (Cal. Code Regs., title 5, § 71475, subd. (t)(3).)
- d. Respondent failed to list the title of the educational programs and other components of instruction offered for each educational program offered. (Cal. Code Regs., title 5, § 71475, subd. (t)(4).)
- e. Respondent failed to list the mode of instruction for each educational program offered. (Cal. Code Regs., title 5, § 71475, subd. (t)(5).)
- f. Respondent failed to list the graduation requirements for each educational program offered. (Cal. Code Regs., title 5, § 71475, subd. (t)(6).)
- g. Respondent failed to identify each occupation and job title to which the institution represents the educational program will lead. (Cal. Code Regs., title 5, § 71475, subd. (t)(7).)
- h. Respondent failed to identify the duly qualified faculty that designed or organized the proposed course or module materials. (Cal. Code Regs., title 5, § 71710, subd. (c).)

FIFTH CAUSE FOR DENIAL OF APPLICATION

(Description of Educational Program)

- 27. Respondent's renewal application is subject to denial on the grounds that it failed to provide details to show that its educational programs satisfy minimum operating standards.

 (Educ. Code §§ 94885, subds. (a)(1), (a)(2), (a)(3), (a)(5), (a)(7) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71700). In particular:
- a. Respondent failed to provide a description of the educational program, for each educational program that it proposes to offer. (Cal. Code Regs., title 5, § 71475, subd. (u)(1).)
- b. Respondent failed to provide compliant syllabi for each educational program it intends to offer. (Cal. Code Regs., title 5, §§ 71475, subd. (u)(7) and 71710, subd. (c).)
- c. Respondent failed to provide a description of the equipment to be used for each educational program it intends to offer. (Cal. Code Regs., title 5, § 71475, subd. (u)(2).)
- d. Respondent failed to provide a description of the number and qualifications of the faculty needed to teach its educational programs. (Cal. Code Regs., title 5, § 71475, subd. (u)(3).)
- e. Respondent failed to provide a projection, and the bases for the projection, of the number of students that the institution plans to enroll in each of the educational programs during each of the three years following the date the application was submitted. (Cal. Code Regs., title 5, § 71475, subd. (u)(4).)
- f. Respondent failed to provide a description of the learning, skills, and other competencies to be acquired by students who complete its educational programs. (Cal. Code Regs., title 5, § 71475, subd. (u)(5).)

SIXTH CAUSE FOR DENIAL OF APPLICATION

24	(Financial Resources and Statements)	
25	28. Respondent's renewal application is subjected to denial on the grounds that	
26	Respondent's submitted financial statements, for the fiscal year ending December 31, 2021, are	
27	not compliant. As a result the Bureau is unable to ascertain whether Respondent is financially	
28	sound and capable of fulfilling its commitments to students. (Educ. Code §§ 94885, subds. (a)(6)	

and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71475, subds. (e) and (w)(2); 71700; 71745; and 74115, subs. (a), (b)(1), (b)(2), (b)(3).) In particular:

- a. Respondent's submitted financial statements were not conducted, prepared, reviewed or audited in accordance with generally accepted accounting principles (GAAP), as required by California Code of Regulations, title 5, section 74115, subdivisions (b)(1), (b)(2), and (b)(3).
- b. Because Respondent's financial statements were not conducted or reviewed in accordance with GAAP, the Bureau is unable to determine if Respondent's financial statements must be reviewed or audited, as required by California Code of Regulations, title 5, sections 71475, subdivisions (e) and (w)(2), and 74115, subdivision (b)(1).
- c. Because Respondent's financial statements were not conducted or reviewed in accordance with GAAP, Respondent has failed to document that is has sufficient assets and financial resources to (1) provide all of the educational programs that the institution represented it would provide; (2) ensure that all students admitted to its educational programs have a reasonable opportunity to complete the programs and obtain their degrees or diplomas; (3) maintain the minimum standards required by the California Private Postsecondary Education Act of 2009 (Educ. Code § 94800 *et seq.*.) and California Code of Regulations, title 5, section 71700 *et seq.*; (4) pay timely refunds as required by the California Private Postsecondary Education Act of 2009, Article 13; (5) pay all operating expenses due within thirty (30) days; and (6) maintain a ratio of current assets to current liabilities of 1.25 to 1.00 or greater at the end of the most recent fiscal year when using generally accepted accounting principles, as required by California Code of Regulations, title 5, section 71745, subdivision (a).

SEVENTH CAUSE FOR DENIAL OF APPLICATION

(Faculty)

29. Respondent's renewal application is subject to denial on the grounds that, following the Bureau's request, Respondent either declined or refused to provide information regarding its faculty member K.O., including that instructor's qualifications, diplomas, transcripts, curriculum vitae, and/or teaching contracts, from which to ascertain whether K.O. is qualified. (Educ. Code

§§ 94885, subds. (a)(5) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71700 and 71720, subd. (b).)

EIGHTH CAUSE FOR DENIAL OF APPLICATION

(Facilities and Equipment)

- 30. Respondent's renewal application is subject to denial on the grounds that its facilities, instructional equipment, and materials are sufficient to enable students to achieve the educational program goals. (Educ. Code §§ 94885, subds. (a)(3) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, § 71700).
- a. Respondent failed to provide a description of the facilities and the equipment which is available for use by students at the main, branch, and satellite locations of the institution. (Cal. Code Regs., title 5, §§ 71260, subd. (a) and 71475, subd. (y)(1).)
- b. Respondent failed to provide the name and address of the lessor or landlord, together with a copy of any use, lease, or rental agreements for its facilities. (Cal. Code Regs., title 5, §§ 71260, subd. (b) and 71475, subd. (y)(2).)
- c. Respondent failed to provide building diagrams or campus maps to assist the Bureau in locating these facilities. (Cal. Code Regs., title 5, §§ 71260, subd. (c) and 71475, subd. (y)(3).)
- d. Respondent failed to provide specifications of significant equipment that demonstrate that the equipment meets the standards prescribed by the Education Code and Education Code section 71100 *et seq.* and is sufficient to enable students to achieve the educational objectives of each education program. (Cal. Code Regs., title 5, §§ 71260, subd. (d) and 71475, subd. (y)(4).)
 - e. Respondent failed to provide, for each item of significant equipment, whether

24	the equipment is owned, leased, rented, or licensed for short-term or long-term, or owned by
25	another and loaned to be used without charge. (Cal. Code Regs., title 5, §§ 71260, subd. (e) and
26	71475, subd. (v)(5).)

f. Respondent failed to provide a list of all permits, certifications, or other

evidence of inspections or authorizations to operate required by the jurisdictions within which the

institution operates that the institution has obtained, and/or an explanation as to why those permits, certifications, or inspections have not yet been obtained. (Cal. Code Regs., title 5, §§ 71260, subd. (f) and 71475, subd. (y)(6).)

NINTH CAUSE FOR DENIAL OF APPLICATION

(Catalog)

- 31. Respondent's renewal application is subject to denial on the grounds that it does not include a compliant school catalog. (Educ. Code §§ 94885, subds. (a)(1) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, § 71700).
- a. Respondent's proposed catalog does not contain the updated specific beginning and ending dates defining the time period covered by the catalog. (Cal. Code Regs., title 5, § 71810, subd. (b)(1).)
- b. Respondent's proposed catalog does not state the type of federal and/or state financial aid available to students, and does not state the consumer information that is required to be disclosed to students pursuant to the applicable federal and state financial aid programs.

 (Educ. Code § 94909, subd. (a)(10).)

TENTH CAUSE FOR DENIAL OF APPLICATION

(Website)

32. Respondent's renewal application is subject to denial on the grounds that Respondent's Internet website fails to include information concerning where students may access the Bureau's Internet website anywhere, on Respondent's website, where the institution identifies itself as being approved by the Bureau. (Educ. Code §§ 94885, subd. (a)(9), 94891, subd. (b), and 94913, subd. (b); and Cal. Code Regs., title 5, §§ 71700).

ELEVENTH CAUSE FOR DENIAL OF APPLICATION

(Graduation or Completion Documents)

33. Respondent's renewal application is subject to denial on the grounds that it fails to include a copy of the document that is awarded to a graduating student upon successful completion of each educational program. (Educ. Code §§ 94885, subds. (a)(7) and (a)(9), and 94891, subd. (b); and Cal. Code Regs., title 5, §§ 71475, subd. (cc) and 71700.)
