Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

## **CITATION**

A Citation is hereby issued to Breining Institute, Owner of Breining Institute (Institution) located at 8894 Greenback Lane, Orangevale, CA, 95662-4019, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

#### BACKGROUND

On October 27, 2017, Bureau staff conducted an announced Compliance inspection at the Institution. As a result, Bureau staff found material violations related to the 2016-2017 School Performance Fact Sheet (SPFS) and SPFS supporting documentation.

#### VIOLATION(S)

#	Below you will find the California Education Code (CEC) and/or Title 5 of the California Code of
	Regulations (5, CCR code) section(s) of law you are charged with violating.

## 1. **Violation**:

# CEC Section 94910 (b)(d)(f)(1)(2)(3) – Minimum Requirements for School Performance Fact Sheet

- "(b) Placement rates for each educational program, as calculated pursuant to Article 16 (commencing with Section 94928), if the educational program is designed to lead to, or the institution makes any express or implied claim related to preparing students for, a recognized career, occupation, vocation, job, or job title.
- (d) Salary or wage information, as calculated pursuant to Article 16 (commencing with Section 94928).
- *(f) All of the following:*

- (1) A description of the manner in which the figures described in subdivisions (a) to (d), inclusive, are calculated or a statement informing the reader of where he or she may obtain a description of the manner in which the figures described in subdivisions (a) to (d), inclusive, are calculated.
- (2) A statement informing the reader of where he or she may obtain from the institution a list of the employment positions determined to be within the field for which a student received education and training for the calculation of job placement rates as required by subdivision (b).
- (3) A statement informing the reader of where he or she may obtain from the institution a list of the objective sources of information used to substantiate the salary disclosure as required by subdivision (d)."

## CEC Section 94929.5(a)(1)(3) - Reporting of Student Performance Data

- "(a) An institution shall annually report to the bureau, as part of the annual report, and shall publish in its School Performance Fact Sheet, all of the following:
- (1) The job placement rate, calculated by dividing the number of graduates employed in the field by the number of graduates available for employment for each program that is either (1) designed, or advertised, to lead to a particular career, or (2) advertised or promoted with any claim regarding job placement.
- (3) Salary and wage information, consisting of the total number of graduates employed in the field and the annual wages or salaries of those graduates stated in increments of five thousand dollars (\$5,000)."

## **CEC Section 94929.7(b) - Documentation of Performance Data**

"(b) An institution shall provide a list of employment positions used to determine the number of graduates employed in the field for purposes of calculating job placement rates pursuant to this article."

Bureau staff reviewed the Institution's website, 2018-2019 School Catalog, and 2016-2017 School Performance Fact Sheet (SPFS) along with the supporting documentation, and found the following violations:

**Violation: CEC Section 94910(b) and 94929.5(a)(1):** The 2016-2017 SPFS failed to contain placement rate.

**Violation: CEC Section 94910(d) and 94929.5(a)(3):** The 2016-2017 SPFS failed to contain salary and wage information.

**Violation: CEC Section 94910(f)(1):** The 2016-2017 SPFS failed to contain a description of the manner in which the figures regarding placement and salary and wage were calculated or a statement with information of where to obtain such a description.

**Violation: CEC Section 94910(f)(2) and 94929.7(b):** The 2016-2017 SPFS failed to contain a statement with information of where to obtain from the Institution a list of the employment positions determined to be within the field for which a student received education and training for the calculation of the job placement rates.

**Violation: CEC Section 94910(f)(3):** The 2016-2017 SPFS failed to contain a statement with information of where to obtain from the institution a list of the objective sources used to substantiate the salary disclosures.

- (m) Documentation supporting all data reported shall be maintained electronically by the institution for at least five years from the last time the data was included in either an Annual Report or a Performance Fact Sheet, and shall be provided to the Bureau upon request; and the data for each program shall include at a minimum:
- (1) the list of job classifications determined to be considered gainful employment for the educational program;
- (2) student name(s), address, phone number, email address, program completed, program start date, scheduled completion date, and actual completion dates;
- (3) graduate's place of employment and position, date employment began, date employment ended, if applicable, actual salary, hours per week, and the date employment was verified;
- (6) a description of all attempts to contact each student. or employer;
- (9) the name, email address, phone number, and position or title of the institution's representative who was primarily responsible for obtaining the students' completion, placement, licensing, and salary and wage data, the date that the information was gathered, and copies of notes, letters or emails through which the information was requested and gathered.
- (n) The institution shall provide on a separate document along with the Performance Fact Sheet the same cancellation disclosure as that which is required to be included with the enrollment agreement by Section 94911(e)(1) of the Code. The separate document shall be substantially the same size as the Performance Fact Sheet and shall be captioned "STUDENT'S RIGHT TO CANCEL" using bold 14 pt. type."

**Violation: 5, CCR Section 74112(a):** The 2016-2017 SPFS failed to contain all and only the information required or specifically permitted by sections CEC 94910 and 94929.5. The SPFS includes additional statements regarding federal loans not permitted by the law. The SPFS does not include placement or salary and wage information, as required by law.

**Violation: 5, CCR Section 74112(h):** The 2016-2017 SPFS failed to contain the proper formatting for the Completion Rates table. The On Time Completion Rates table is missing the program length from the title line. The Program Length does not match the program length that the Bureau has on file. The SPFS lists "(scheduled completion within two years)", however, the Bureau has the Addiction Studies Certificate listed as a 350-hour clock hour program.

**Violation: 5, CCR Section 74112(i)(4):** The 2016-2017 SPFS failed to contain the proper formatting for the Job Placement table and Gainful Employment tables. Under the Job Placement section, the Institution provided a statement that the educational program is not designed to lead to a particular career, occupation, vocation, job title, job classification or field.

**Violation: 5, CCR Section 74112(k):** The 2016-2017 SPFS failed to contain the proper formatting for the Salary and Wage table. Under the Salary and Wage section, the Institution provided a statement that the educational program is not designed to lead to a particular career, occupation, vocation, job title, job classification or field.

**Violation: 5, CCR Section 74112(m)(1):** The 2016-2017 SPFS supporting documentation failed to include the list of job classifications determined to be considered gainful employment for the educational program.

**Violation: 5, CCR Section 74412(m)(2):** The 2016-2017 SPFS supporting documentation failed to include address, phone number, email address, scheduled completion date.

**Violation: 5, CCR Section 74112(m)(3):** The 2016-2017 SPFS supporting documentation failed to include graduate's place of employment and position, date employment began, date employment ended, if applicable, actual salary, hours per week, and the date employment was verified.

**Violation: 5, CCR Section 74112(m)(6):** The 2016-2017 SPFS supporting documentation failed to include a description of all attempts to contact each student. or employer.

**Violation: 5, CCR Section 74112(m)(9):** The 2016-2017 SPFS supporting documentation failed to include the name, email address, phone number, and position or title of the Institution's representative who was primarily responsible for obtaining the students' completion, placement, licensing, and salary and wage data, the date that the information was gathered, and copies of notes, letters or emails through which the information was requested and gathered.

**Violation: 5, CCR Section 74112(n):** The 2016-2017 SPFS failed to contain the Institution's cancellation disclosure.

#### Order of Abatement:

The Bureau orders the Institution to submit to the Bureau a policy, or procedure, of how the Institution will maintain future compliance with 5, CCR section 74112.

## **Assessment of Fine**

The fine for this violation is \$5,000.00

## **TOTAL ADMINISTRATIVE FINE DUE: \$7,500.00**

## **ASSESSMENT OF A FINE**

In accordance with CEC section 94936; and 5, CCR sections 75020 and 75030, the Bureau hereby orders this assessment of fine in the amount of \$7,500.00 for the violations described above. Payment must be made, to the Bureau, within 30 days from the date of service of the Citation.

## COMPLIANCE WITH ORDER OF ABATEMENT

In accordance with the provisions of CEC section 94936 and 5, CCR section 75020 the Bureau hereby issues the order(s) of abatement described above. **Evidence of compliance with the order(s) of abatement must be submitted, to the Bureau, within 30 days** from the date of service of the Citation.

## APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **October 2, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

## EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **September 3**, **2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **October 2**, **2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.

The Bureau will promptly take all appropriate action to enforce this Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
