On September 11, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1920015 (Citation) against California Northstate University, LLC, Owner of California Northstate University, LLC (Institution). In attendance were Marina O'Connor, Licensing Chief, Norine Marks, Attorney and Paul Wagstaffe, Attorney.

Pursuant to Business and Professions Code, §148; California Education Code (CEC), section 94944; and Title 5 of California Code of Regulations (5, CCR), section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1920015.

It is the decision of the Licensing Chief that on November 13, 2019 Citation No. 1920015 is <u>modified</u> and makes the following change(s):

	On April 23, 2018, Bureau staff found that the Institution was advertising three programs not approved by the Bureau: Bachelor of Science Health Science-to-Doctor of Medicine (BS-MD), Bachelor of Science-to-Doctor of Pharmacy (BS-PharmD), and Pre-Medical Post Baccalaureate (PMPB).					

	On August 23, 2018, the Bureau approved the PMPB Non-Degree program.						
	As of July 18, 2019, the Bureau has not received a Change of Educational Objectives Licensing application to obtain approval to offer the BS-MD and BS-PharmD program.

"(1) Definitions. Definitions for all terms contained on the Performance Fact Sheet shall be included as part of the Performance Fact Sheet, in the same format as required in subdivision (a). The following are the definitions for the Performance Fact Sheet:

"Number of Students Who Began the Program" means the number of students who began a program who were scheduled to complete the program within 100% of the published program length within the reporting calendar year and excludes all students who cancelled during the cancellation period. "Students Available for Graduation" is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.

"Number of On-time Graduates" is the number of students who completed the program within 100% of the published program length within the reporting calendar year.

"On-time Completion Rate" is the number of on-time graduates divided by the number of students available for graduation.

"150% Graduates" is the number of students who completed the program within 150% of the program length (includes on-time graduates).

"150% Completion Rate" is the number of students who completed the program in the reported calendar year within 150% of the published program length, including on-time graduates, divided by the number of students available for graduation.

"Graduates Available for Employment" means the number of graduates minus the number of graduates unavailable for employment.

"Graduates Unavailable for Employment" means the graduates who, after graduation, die, become

"Graduates Employed in the Field" means graduates who beginning within six months after a student completes the applicable educational program are gainfully employed, whose employment has been reported, and for whom the institution has documented verification of employment. For occupations for which the state requires passing an examination, the six months period begins after the appouncement of the examination results for the first examination available after a student completes

announcement of the examination results for the first examination available after a student completes an applicable educational program.

"Placement Rate Employed in the Field" is calculated by dividing the number of graduates gainfully employed in the field by the number of graduates available for employment.

"Number of Graduates Taking Exam" is the number of graduates who took the first available exam in the reported calendar year.

"First Available Exam Date" is the date for the first available exam after a student completed a program.

"Salary" is as reported by graduate or graduate's employer.

"No Salary Information Reported" is the number of graduates for whom, after making reasonable attempts, the school was not able to obtain salary information."

(m) Documentation supporting all data reported shall be maintained electronically by the institution for at least five years from the last time the data was included in either an Annual Report or a Performance Fact Sheet, and shall be provided to the Bureau upon request; and the data for each program shall include at a minimum:

**Violation: CEC Section 74112 (a)**: The Institution used the wrong format on the 2015/2016 SPFS for the Doctor of Medicine and Bachelor of Science in Health Sciences (BSHS). Additionally, In addition, the 2015/2016 SPFS for the Doctor of Pharmacy program, the Institution included a disclosure in the Job Placement Rates section, which is not allowed per 5, CCR Section 74112 (a).

**Violation: 5, CCR Section 74112 (h)**: The 2015/2016 SPFS for the Doctor of Pharmacy program reported 150% Completion Rates but failed to report four years data.

**Violation: 5, CCR Section 74112 (i)(1)**: The 2015/2016 SPFS for the BSHS program failed to contain the Job Placement Rates and Gainful Employment Categories.

**Violation: 5, CCR Section 74112 (i)(3)**: Institution staff did not have access to the list of job classifications and corresponding SOC codes and were unable to provide the list to Bureau staff upon request.

**Violation: 5, CCR Section 74112 (i)(4)**: The 2015/2016 SPFS for the Doctor of Pharmacy program failed to accurately report "Graduates Employed in the Field".

**Violation: 5, CCR Section 74112 (j)**: The 2015/2016 SPFS for the BSHS program failed to contain the License Examination Passage Rates table.

	<b>Violation: 5, CCR Section 74112 (k)</b> : The 2015/2016 SPFS for the Doctor of Pharmacy program failed to accurately report "Graduates Employed in the Field" and Salary and Wage Information. Additionally, the 2015/2016 SPFS for the BSHS program failed to contain the Salary and Wage Information table.
	Violation: 5, CCR Section 74112 (I): The 2015/2016 SPFS for the BSHS program failed to contain the required definitions.
	<b>Violation: 5, CCR Section 74112 (m)</b> : Institution staff did not have access to the supporting documentation for the 2015/2016 SPFS and was unable to provide it to Bureau staff upon request.
	Order of Abatement:
	The Bureau orders the Institution to maintain compliance with 5, CCR section 74112 and shall submit a written policy of how future compliance with 5, CCR section 74112 will be maintained.
	<u>Assessment of Fine</u> The fine for this violation is <u>\$5000.00</u>
	Reason for modification: New substantive facts were presented at the conference.
	The administrative fine for this violation has been modified from \$5,000.00 to <u>\$3,500.00</u> .

#### APPEAL OF CITATION

You *do not* have the right to request another Informal Conference to appeal this modified Citation. You *do*, however, have the right to appeal this affirmed or modified Citation through an Administrative Hearing A hearing before an Administrative Law Judge will be scheduled and you will be notified of the hearing date. The hearing will be held pursuant to Chapter 5 (commencing with section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you do not wish to appeal this modified Citation you must withdraw your initial request for an Administrative Hearing, if one was made. Please complete and mail the enclosed <u>Withdrawal –</u> <u>Request for Administrative Hearing</u> within <u>**30 Days**</u> of the date of this decision.

### EFFECTIVE DATE OF CITATION AND FINE ASSESSMENT

This modified Citation is effective on November 20, 2019. The Order of Abatement and payment are due by **December 20, 2019**.

Failure to abate the violation or to pay the administrative fine within the time allowed is grounds for denial of an application for an approval to operate or discipline. The Bureau will promptly take all appropriate action to enforce the Modified Citation and recover the civil penalties prescribed therein or found to be due after a hearing.
