LICENSING HISTORY

1. On or about October 11, 2017, the Bureau issued an Approval to Operate a Private Postsecondary Institution to App Academy (hereinafter referred to as the "Institution"). This Approval to Operate expired on or about October 11, 2022, and is pending renewal. An application for renewal of the Institution's Approval to Operate a Private Postsecondary Institution was received on October 11, 2022 and is under review.

Cause for Citation: A review of the Bureau's records confirm the Institution failed to submit a 2022 Annual Report. The report was due to the Bureau by December 1, 2023.

If you wish to contest this citation, you may submit a written request to the Bureau or submit the enclosed Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing form within 30 days from the date of issuance of this citation.

Failure to submit a written request for an informal conference and/or administrative hearing within 30 days from the date of issuance of this citation will forfeit your ability to appeal the citation.

If a hearing is requested, you are not required to comply with this citation until a final order is entered against you.
