		 (13) Total institutional charges paid. On January 18, 2023, I requested Estes' most current STRF substantiating data. Estes' Director Susan Winey provided me with Estes' STRF substantiating data for the 3rd quarter of 2022. I reviewed their substantiating data and found it was missing several sections of required student information. Their STRF data is missing the following required student data: (1) Student identification number, (3) Email address, (4) Local or mailing address, (5) Address at the time of enrollment, (6) Home address, (7) Date enrollment agreement signed,

 (8) Courses and course costs, (9) Amount of STRF assessment collected, (10) Quarter in which the STRF assessment was remitted to the Bureau, (11) Third-party payer identifying information, (12) Total institutional charges charged, and (13) Total institutional charges paid. 	
To remedy this deficiency, Estes shall provide the Bureau with updated STRF substantiating data for the 3 rd quarter of 2022 and notify the Bureau how it will maintain STRF substantiating data as required by 5, CCR 76140(a)(1-13).
