Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

### **CITATION**

A Citation is hereby issued to Medical Imaging Education Systems, Inc., Owner of JEM College (Institution) located at, 11850 Pierce Street, Suite 100, Riverside, CA 92505, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) section 94936; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

### BACKGROUND

All institutions are required to submit a Student Tuition Recovery Fund (STRF) Assessment Reporting Form to the Bureau no later than the last day of the month following the close of the quarter.

Pursuant to CEC section 94923(a) The Student Tuition Recovery Fund relieves or mitigates economic loss suffered by a student while enrolled in an institution not exempt from this article pursuant to Article 4 (commencing with section 94874), who, at the time of his or her enrollment, was a California resident or was enrolled in a California residency program, prepaid tuition, and suffered economic loss.

The Bureau sends notifications/reminders to all approved institutions 30 days prior to close of each quarter.

As of June 25, 2020, the Institution has not submitted the STRF Assessment Reporting Forms for the 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> quarters of 2016, 1<sup>st</sup> quarter of 2017, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> quarters of 2018, 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> quarters 2019, and 1<sup>st</sup> quarter of 2020.

All institutions are required to pay annual fee within 30 days of the date on which the Institution originally receives its approval to operate and each year thereafter on the anniversary of the date of the original approval. An institution shall pay its annual fee in addition to any other applicable fees.

Pursuant to CEC section 94930.5 (g). effective July 1, 2018, the annual fee for each campus described in subparagraphs (A) and (B) of paragraph (1) of subdivision (d) shall be in an amount equal to 0.55 percent of that campus' total gross revenue derived from students in California, but not to be less than two thousand five hundred dollars (\$2,500) and not to exceed sixty thousand dollars (\$60,000) for each campus.

As of June 25, 2020, the Bureau has not received the annual fee for the calendar year 2018 from the Institution and has not received late payment penalty fee for calendar years 2017, 2018, and 2019.

### 2018 Annual Fee \*and Late Payment Penalty\*

As of June 25, 2020, the Bureau has not received the annual fee nor the 90-day late payment penalty fee from the Institution.

### 2017 Late Payment Penalty

The Institution failed to pay its 2017 late payment penalty fee for calendar year 2017.

On January 16, 2018, the 1<sup>st</sup> delinquency notice (Invoice # 900331142) was sent via mail at 11850 Pierce Street, Suite 100, Riverside, CA 92505, stating that the annual fee for calendar year 2017 was due on December 1, 2017.

On February 7, 2018, the Bureau received the 2017 annual fee in the amount of \$2,500.00. However, the penalty fee was not included with the fees submitted. As of June 25, 2020, the Bureau has not received the 30-day late payment penalty fee from the Institution.

### 2019 Late Payment Penalty

The Institution failed to pay its 2017 late payment penalty fee for calendar year 2019.

On November 1, 2019, the Institution was notified (Invoice #900339481) via mail at 11850 Pierce Street, Suite 100, Riverside, CA 92505, stating that the annual fee for calendar year 2019 was due on December 1, 2019.

On January 7, 2020, the Bureau received the 2019 annual fee in the amount of \$2,500.00. However, the penalty fee was not included with the fees submitted. As of June 25, 2020, the Bureau has not received the 30-day late payment penalty fee from the Institution.

### Order of Abatement:

The Bureau orders the Institution to submit its annual fees for calendar year 2018 in accordance with 5, CCR section 74006(a)(b) and CEC section 94930.5(g). In addition, the Institution must pay

all late payment penalty fees for calendar years 2017, 2018, and 2019.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference **and/or** Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.* 

Unless a written request for an informal conference **and/or** an administrative hearing is signed by you and delivered to the Bureau by **July 25, 2020**, you will be deemed to have waived or forfeited your right to appeal this matter.

### **EFFECTIVE DATE OF CITATION**

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective **on June 25, 2020**. Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **July 25, 2020**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.

If a hearing is requested, you will not be required to comply with this Citation until 30 days after a final order is entered against you.
