Correction: The institution shall remove from the website, the pop-up box that requires a prospective student to provide personal contact information in order to obtain, educational program information that is required to be contained in the school catalog pursuant to CEC § 94897 (o).

2	CEC § 94913 (a) (1-5) that is consistent with5 CCR § 74117	Violation Description: The institution's website failed to include any required items pursuant to CEC § 94913 (a) (1-5). No items were found on the home page of the website pursuant to 5 CCR § 74117.  Correction: The institution shall add to the homepage of the website clear and conspicuous links to all of the required items listed pursuant to CEC § 94913(a) (1-5) in conjunction with 5 CCR § 74117.

Pursuant to 5 CCR section 75010(d), the Institution may do either of the following:

- (1) Within 30 days from the date of the inspection, sign and return the notice to comply, declaring under penalty of perjury that the violation was corrected and describing how compliance was achieved; or
- (2) Within 30 days from the date of the inspection, file with the Bureau a written notice of disagreement, specifying the minor violations described in the notice to comply with which the person approved to operate the institution disagrees, and appealing it by requesting an informal office conference. If a written notice of disagreement is not timely filed with the Bureau, the right to appeal is deemed to have been waived.

Pursuant to CEC section 94935(h), failure to comply with the notice to comply will result in the Bureau taking appropriate administrative enforcement action.

The Notice to Comply was given to the Institution's owner, person in control, chief academic officer, chief executive officer, chief operating officer, institution director, or any person delegated by any of the aforementioned persons to facilitate the inspection or accept such notice as set forth below.
