Christina Villanueva issues this Citation: Assessment of Fine and Order of Abatement (Citation) in her official capacity as Discipline Manager of the Bureau for Private Postsecondary Education (Bureau) of the California Department of Consumer Affairs.

<u>CITATION</u>

A Citation is hereby issued to The Los Altos Software Testing House, Luiza Yusupova, Owner of Portnov Computer School (Institution) located at 4966 El Camino Real #123, Los Altos, CA 94022, pursuant to Business and Professions Code section 125.9; California Education Code (CEC) sections 94936 and 94932; and Title 5 of the California Code of Regulations (5, CCR) section 75020 for the violations described below.

BACKGROUND

On August 19, 2021, Bureau staff conducted an unannounced Compliance inspection at the Institution. As a result, a potential material violation was found related to student records.

VIOLATION

the appropriate enrollment documents are provided to them through the website.

Order of Abatement:

The Bureau orders the Institution to submit copies of School Performance Fact Sheets (SPFS) signed by its students that are currently enrolled. In addition, the Bureau orders the Institution to submit a written policy, or procedure, of how future compliance will be maintained in accordance with 5, CCR Section 71920.

ASSESSMENT OF A FINE

APPEAL OF CITATION

You have the right to contest this Citation through an informal conference with the Bureau; and/or through an administrative hearing in accordance with Chapter 5 (Commencing with Section 11500) of Part 1 of Division 3 of Title 2 of the Government Code.

If you wish to contest this Citation, you must submit the 'Notice of Appeal of Citation – Request for Informal Conference and/or Administrative Hearing' form (enclosed) within <u>30 days</u> from the date of service of the Citation. *If you do not request an informal conference and/or an administrative hearing within 30 days from the service of the Citation, you will not be able to request one at a later time.*

Unless a written request for an informal conference and/or an administrative hearing is signed by you and delivered to the Bureau by **April 29, 2022**, you will be deemed to have waived or forfeited your right to appeal this matter.

EFFECTIVE DATE OF CITATION

If you do not request an informal conference and/or an administrative hearing, this Citation shall become effective on **March 30, 2022.** Payment of the administrative fine and evidence of compliance with the order(s) of abatement shall be due by **April 29, 2022**. Your payment of the administrative fine shall not constitute an admission of the violation(s) charged.
