On February 14, 2019, an informal telephone conference was held in the matter of Citation: Assessment of Fine and Order of Abatement No. 1819084 (Citation) against Union University of California, Owner of Union University of California. In attendance were Beth Scott, Enforcement Chief; and Son Xuan Nguyen, Agent

Pursuant to Business and Professions Code, section 125.9; California Education Code, section 94936; and Title 5 of the California Code of Regulations, section 75020 and section 75040, the Bureau for Private Postsecondary Education (Bureau) renders the following decision relative to your appeal of the Citation No. 1819084.

It is the decision of the Enforcement Chief that on February 14, 2019 Citation No. 1819084 is modified and makes the following change(s):

- (6) a description of all attempts to contact each student. or employer;
- (7) any and all documentation used to provide data regarding license examinations and examination results;
- (8) for each student determined to be unavailable for graduation or unavailable for employment, the identity of the student, the type of unavailability, the dates of unavailability, and the documentation of the unavailability; and
- (9) the name, email address, phone number, and position or title of the institution's representative who was primarily responsible for obtaining the students' completion, placement, licensing, and salary and wage data, the date that the information was gathered, and copies of notes, letters or emails through which the information was requested and gathered.

On June 22, 2018, the Institution representative stated they had documentation to substantiate the data reported in the 2015/2016 SPFS but could not provide the data for review as representative in charge of submitting the Annual Report was in Vietnam.

### Order of Abatement:

The Bureau orders the Institution to submit the supporting documentation used to substantiate the data reported in the 2015/2016 SPFS. In addition, the Bureau orders the Institution to submit an established policy and procedure ensuring that all records are maintained by the Act and the Chapter and shall be readily available to the Bureau upon request during normal business hours.

Reason for modification: New substantive facts were presented at the conference.

The administrative fine for this violation has been modified from \$5,000.00 to \$250.00.

# 2. Violation

# 5, CCR Section 71930 (e) Maintenance of Records

(e) All records that the institution is required to maintain be the Act or this chapter shall be made immediately available by the institution for inspection and copying during normal business hours by the Bureau and any entity authorized to conduct investigations.

On June 22, 2018, the Institution representative stated that they did not have access to the supporting documentation and was unable to provide the documentation to the Bureau upon request.

The Bureau orders the Institution to submit an established policy and procedure ensuring that all records are maintained by the Act and the Chapter and shall be readily available to the Bureau upon request during normal business hours.

Reason for modification: New substantive facts were presented at the conference.

The administrative fine for this violation has been modified from \$5,000.00 to \$250.00.

#### APPEAL OF CITATION
